HASTEN consistently outperforms other oil-based adjuvants due mainly to its superior penetration properties. HASTEN is generally safe to see product label for specific uses.





Use Rate Guidance

For most herbicides applications the usage rate for **HASTEN** is specified as volume % in the range 0.5 - 1.0L/100L. Typical spray volume for these applications is in the range 40 - 100L/ha. Refer to herbicide product label for specific directions.

When using **HASTEN** for other applications ...

The recommended usage rate of **HASTEN** for all such applications should be approximately 0.5 - 1.0 L / ha and should not be less than 0.2 L / ha (see Table below).
